BCT Suppliers Lists - The Geographic Distribution of BCT Expenditure 1999-2012

BCT is committed as a local community trust to ensuring that, taking all factors into account:-

- (a) as much as possible of its expenditure each year is local; &
- (b) there is a reasonably wide distribution of that expenditure amongst different local suppliers.

BCT has monitored its performance against these aims since it started 14 years ago. BCT analyses its annual expenditure by allocating the locations of its suppliers between four geographic areas on the basis of their invoice address and then totaling the number of suppliers and expenditure in each area.

The results for 12 of the 14 years to date are shown below. Data for the other two years (2005, 2006) is not accessible due to computer difficulties. As reported previously, the consistent pattern over the years has been for 75% or more of BCT's expenditure each year to be in the immediate local area of Birse and Mid Deeside and to an average of 25 or more local suppliers each year.

The figures for 2012 maintained this pattern. While the level of expenditure and the total number of suppliers were the lowest over the 14 years to date, the percentage of the expenditure made to suppliers in the parish still remained high.

BCT's total expenditure over the fourteen years to date (excluding property purchases) has been £1.16 million. The high percentage of this expenditure that has been spent locally represents inward investment into the area, as BCT has secured the overwhelming majority of its income from sources outside the area.
